

June 30 2020 Offer Terms & Conditions

Offer 1

1. For product purchased (ordered and paid for) before 26th June 2020 and collected from Summit storage after 30th June 2020 and before 31st July 2021.
2. Product not collected by 31st July 2021 will be returned to Summit's stock and monies paid in June 2020 will be credited to the Customer's Account less a 10% Administration and Restocking Fee.
3. Product ordered must be collected from Summit storage before the same product can be collected under any other Summit 2020/21 Fertilizer Contract.
4. The offer is available on most of Summit's product range, although some products will be restricted on first come first served basis due to limited supply.
5. The sales contract is on a fixed price basis irrespective of whether international prices move up or down during the 2020/21 season. In all other respects the sales contract is subject to Summit Fertilizers' General Conditions of Sale (see www.summitfertz.com.au/legal).
6. If the customer chooses a 10% deposit option as payment then the 10% deposit must be paid prior to the 26th of June 2020 and the sum payable will be 10% of the total invoice value including GST. The outstanding balance will be due and payable no later than the 25th of January 2021 or on collection if prior to this date.
7. All orders or contracts must be accompanied by a Commitment Number issued by Summit Fertilizers.
8. Orders will be confirmed if payment is made by Friday 26th June 2020. Orders not paid in full by 29th June 2020 will be cancelled.
9. Product is invoiced before 30th June 2020 and as such is owned by the customer and held in storage by Summit.
10. No product changes or refunds are available after 30th June 2020 and product must be collected before 31st July 2021.
11. No other discount offers can be used in conjunction with this offer.
12. This offer is not open to resellers or buying groups.
13. The purchase price includes product insurance up until the product has been collected from Summit storage.
14. The 2019/20 Fertilizer Supply Offer Terms and Conditions also apply to any orders placed under this offer. These terms and conditions will prevail to the extent of any inconsistency.

Offer 2

1. Pre-pay a lump sum amount into your Summit Fertilizers account before the 26th June 2020 which will be invoiced as “EOFY 2020 Pre-paid Fertilizer” prior to 30th June 2020.
2. No cash refunds will be available. Funds will be held in your Summit Fertilizers account and must be used for fertilizer purchases only. Any unused funds remaining on the 30th June 2021 will be returned to the customer less a 10% administration fee.
3. Pre-paid funds can only be used for collections between 1st October 2020 and the 30th June 2021.
4. Fertilizer nominated must be contracted in the 2020/21 “Summit Fertilizer Supply Offer” under a Variable or Fixed Price order. The 2020/21 Fertilizer Supply Offer Terms and Conditions also apply to any orders placed under this offer.
5. Pre-paid fertilizer purchases must have products nominated no later than the month prior to the requested collection month. Pre-paid funds must be applied to the earliest fertilizer dispatches from product nominated in the “Summit Fertilizer Supply Offer”.
6. Any product remaining on a variable order will be converted to a Fixed Price Contract no later than one month prior to the nominated collection month.
7. All products purchased are subject to availability at the time of nomination.
8. No other discount offers can be used in conjunction with this offer.
9. This offer is not open to resellers or buying groups.
